## PROGRAM STRUCTURE

This is a full-time program of 60 ECTS credits. The program offers 24 different courses focusing on various aspects of European and international business law. About half of all courses are optional, offering different varieties of specialization. Lecturers are renowned professionals of their field, both as academics and practitioners from law firms, judiciary and top-level international or domestic legal organizations. Visiting lecturers from a number of other countries are also incorporated in the program. The program is concluded with the defense of the master thesis and passing the final exam.

The academic year is divided into five teaching modules, each consisting of five teaching weeks and one week for exams.

## ADMISSIONS CRITERIA AND THE APPLICATION PROCESS

Applicants should have a valid degree in law from any recognized university in the World.

A number of international language exams are available to satisfy the language requirements to apply to the program (TOEFL, IELTS, Pearson, Cambridge Proficiency and Cambridge Advanced). Applicants have to supply a number of annexes, the list of which is available on the program home-page (application form, CV, letter of motivation, a short essay in law, two letters of recommendation, etc.).

Registration fee is EUR 30.-, non-refundable. The registration fee of admitted applicants is recognized towards the tuition.

Application is a two-step system: the first phase is electronic (via e-mail). Selection of the 30 students for the program and also a waiting list of the next five students is made upon the electronic applications. In the second step, selected applicants must supply hard copies of the electronically submitted documents (for notarization and legalization requirements - see the program home-page).

Waiting list: if an applicant falls short of supplying authenticated hard copies of the application material, or fails to pay the tuition, withdraws from, or for any other reason does not start or falls out of the studies, the applicant next on the waiting list is admitted.

**Tuition due:** 28 August 2015 / 11 September 2015  
(extended application admissions)

**Maximum number of students:** 30

**Student welfare services provide aid in:**

visa application, public administration for foreigners, social security and medical coverage, and in finding accommodation, etc.

**The tuition covers** participation in the program, receipt of the degree, electronic course materials, library use and access to a number of legal databases, extracurricular activities (e.g. moot court participation), some program-related social events (receptions), and student welfare services (aid in visa application, intermediation in public administration for foreigners, social security, medical services and in finding accommodation, participation in the local student-buddy program).

**The tuition does not cover** living expenses, travel expenses, social security and medical coverage, fees in public administration, accommodation, social events unrelated to the LL.M. program, etc.
