

Résumé of doctoral thesis authorship Maksymilian Ślusarczyk, entitled „Centers of financial supervision use in Poland and European Union in respect of banks”.

Analysis of catalog of centers of supervision is purpose of the doctoral thesis, that belong Commission of Financial Supervision and Committee of Financial Stability in Poland and European Systemic Risk Board European Banking Authority at the level of European Union. Centers of financial supervision is particular object of interest within the confines of said analysis at the nature unvalid, which have been subjected estimate for their usefulness in fulfilling financial oversight in Poland that and on rung of European Union. Results carried indicate within the confines of the doctoral thesis consideration legitimacy put in to its content of postulate of expansion of range of application by organs of financial unvalid oversights of centers of supervision.

Admission starts doctoral thesis to topic of financial oversight with indication of reason of essentiality of discussed stuff presenting general introduction. Doctoral thesis has been divided on 4 chapters next from among, each concerns important aspect of financial supervision in Poland and on rung of European Union.

Chapter first is concentrated on indication, definition and from range of financial supervision discussion of basic question. This element remains key the doctoral thesis definition of notion „control” and „supervision” and installation of their mutual attitude.

Chapter second has been devoted presentation of stuff of model of financial supervision, that presently function in Poland, chosen countries of membership European Union and on rung of European Union. Wide discussion of problems of model of supervision was indispensable within the confines of this chapter for exerting influence on efficiency of application of centers of financial supervision that has each model.

Chapter third presents detailed discussion of structure, principles of functioning and in the form of Commission of Financial Supervision and Committee of Financial Stability in Poland and European Systemic Risk Board European Banking Authority at the level of European Union. Many problems which are a result of legal solutions concerned mentioned supervision authorities have been indicated in this chapter. The chapter presents organizational structure, purposes and tasks of Central European Bank as a supervision authority.

Chapter fourth concerns centers of financial supervision. Attempt of define and explanation centers of financial supervision in to its role in prosecution of financial supervision has been taken in thic chapter. In te chapter ha salso been taken an analysis of centers of supervision that polish and union organs of financial superwision has been furnished. Centers of supervision have been subjected analysis under their corners of procedures of application, that evoke for subjects overseen results and efficiency . Besides, in the fouth chapter it is written that financial supervision has very important meaning for consumer protection in Poland and on rung of European Union. The fourth chapter also includes postulates concerning wider using of unbinding centers of financial supervision by organs of financial supervision. There are also agreements about deal of delegation of task and dispositions regulated in article 28 settled in Regulation (EU) no 1093/2010 of The European Parliament and of The Council of 24 November 2010 establishing a European Supervisory Authority (European Banking Authority), amending Decision No 716/2009/EC and repealing Commission Decision 2009/78/EC (Dz.U.U.E.L.2010.331.12), as well as introduce of „repair mode” as an alternatives for modern centers of supervision for becoming financial supervision more effective.

Ending of the doctoral thesis includes assessments about matters that have been moved in the doctoral thesis. Besides, there are postulates, that could be useful to make financial supervision more effective and financial sector more safe.
